Whereas Government of Punjab, Punjab Small Industries & Export Corporation Limited, Udyog Bhawan, Sec - 17 A, Chandigarh under the Department of Industries & Commerce, Punjab, In the Industrial and Business Development Policy, 2017 of Department of Industries lays emphasis specially on introducing and practicing the concept of Ease of Doing Business in relation to providing different nature of clearances to the plot holders taking holistic view of the situation and to accelerate the pace of providing clearances to the entrepreneurs in pursuit of implementation of their project, Board of Directors of Corporation in its meeting held on 17.12.2018 has decided that work relating to the passing of building plans of industrial plots allotted by PSIEC in different focal points / Growth Centres shall be undertaken by Department of Housing & Urban Development and Department of Local Govt as under :

- i) Concerned Municipal body under Department of Local Government for the areas falling under their respective jurisdiction.
- ii) Concerned authority of Department of Housing & Urban Development, Govt. of Punjab for areas falling beyond the municipal limits.
- iii) While processing the cases of passing of building plans, the concerned agency(s) will obtain No Objection Certificate from PSIEC in time bound manner.

For processing of building plans of industrial plots allotted by PSIEC in different focal Points / Growth Centers, Department of Local Bodies and Department of Housing & Urban Development will follow building bye-laws of their respective Department.

The above order shall be effective from the date of notification.
