No. Whereas in order to develop Firozpur Town and its surroundings in an orderly manner, and to prepare Master Plan under "The Punjab Regional and Town Planning and Development Act, 1995, Local Planning Area, Firozpur was declared vide Notification No. 12/23/2007-4HG1/8906, dated 08-11-2007 and 12/23/2007-4HGI/1899 dated 16-06-11 under section 56 (1) & (7) of the Act *ibid*.


Whereas Chief Town Planner, Punjab, was declared as Planning Agency for aforesaid Local Planning Area under section 57 of "The Punjab Regional and Town Planning and Development Act 1995" vide notification No. 12/23/2007-4HG1/8912, dated 08/11/2007

Whereas Planning Agency prepared the Master Plan for Local Planning Area, Firozpur and published the same in news paper on 27.07.2014 under Section 70 (3) of "The Punjab Regional and Town Planning and Development Act, 1995", for inviting objections from the general public.

Whereas objections received from the general public were considered by the Government in consultation with The Punjab Regional and Town Planning and Development Board in its 29th meeting held on 15.04.2015 and approved the Master Plan, Firozpur.


Now, therefore in exercise of powers conferred under Section 70 (5) of "The Punjab Regional and Town Planning and Development Act, 1995" final Master Plan, Firozpur comprising written report and drawings namely Existing Landuse Plan-2011 Drawing No. D.T.P (F) 62/2011 dated 04-3-2011, Proposed Landuse Plan (2011-2031) Drawing No. D.T.P (F) 94/2014 dated 22-05-2014, are hereby notified.
